

#### **2023 Pavement Preservation Project**

The 2023 Pavement Preservation Project includes pavement repairs, micro surfacing, slurry seal, restriping of pavement markings, and bicycle striping improvements of various streets in the unincorporated areas of San Mateo County

- 15.48 miles
- West Menlo Park, Stanford Weekend Acres, and Ladera Areas
- Bid Opening Scheduled for Thursday, May 4, 2023
- Engineer's Estimate \$2,442,000
- Duration: 60 Working Days
- Construction Start Mid June






## Broadmoor Safe Routes to School Pedestrian Improvements Project

Crosswalk improvements at 3 locations and slurry sealing of 87th Avenue between S. Park Plaza and the County limit near Pinehaven Drive.

- 1.25 miles
- Broadmoor Area
- Bid Opening held on Tuesday, March 28, 2023
- Low Bid: \$1,504,846
- Contractor: Bay Area Lightworks
- Duration: 40 Working Days
- Construction Start May/June



## Broadmoor Safe Routes to School Pedestrian Improvements Project








# Bunker Hill Drive and Avenue Alhambra Safe Routes to School Pedestrian Improvements Project

- Bid Opening held on Wednesday, April 12, 2023
- Low Bid: \$249,943
- Contractor: Bay Area Lightworks
- Duration: 30 Working Days
- Construction Start May/June

- Construction to start summer of 2023






#### **Bay Road Complete Streets Project**

Description: Joint effort with the City of Redwood City to make multi-modal improvements for all road uses who use or cross Bay Road between 5<sup>th</sup> Avenue and 15<sup>th</sup> Avenue/Spring Street.

- Awarded OBAG 3 Grant for design and construction of \$3.8 million.
- Working to execute grant agreement
- Public outreach/community input
- Design 2023/2024
- Construction 2024





## Santa Cruz Avenue and Alameda de Las Puglas Improvements

Description: Multi-modal improvements on Santa Cruz Avenue from Sand Hill to Alameda de las Puglas, along Alameda de las Pulgas from Santa Cruz to Avy Avenue. Road diet, bicycle, and pedestrian improvements.


- Awarded San Mateo Transportation Authority Grant of \$700K for design
- Awarded Caltrans Regional Active Transportation Program (ATP)
   Cycle 6 of \$5.435 million for construction
- Community meeting held on 4/18, with 50+ attendees to provide update on current design, address issues/concerns
- Need to digest community comments, and determine next steps
- Current schedule has final design completed in 2023 and construction in summer of 2024



#### Vine Street Reconstruction

Description: The Project involves the roadway reconstruction of Vine Street from Oak Avenue to County/City Boundary near Leland Avenue in the unincorporated West Menlo area.

- Property Owner Survey send 12/20/2022
- Public Meeting Held 1/11/2023
- Survey Due to County 1/27/2023
- Survey results indicate property owners do not want a project, included in 2023 Pavement Preservation Project





#### **2024 West Menlo Reconstruction**

Description: The Project involves the roadway reconstruction of Camino al Lago, Palo Alto Way and Perry Avenue in the unincorporated West Menlo area.


- Field investigation and marking of options
- Preparation of Property Owner Notification and Survey
- Future community meeting will be scheduled
- Results of survey will dictate if project moves forward



#### 2024 NFO Reconstruction – 16th Avenue

Description: The Project involves the roadway reconstruction of 16<sup>th</sup> Avenue from 15<sup>th</sup> Avenue to the end.

- Field investigation and marking of options
- Preparation of Property Owner Notification and Survey
- Future community meeting will be scheduled
- Results of survey will dictate if project moves forward





# 2023 Safetrec Grant – Hillside Blvd and Guadalupe Canyon Road

Description: Grant awarded through UC Berkeley to prepare a Complete Streets Safety Assessment of Hillside Blvd between Hoffman Street and E. Market Steet, and Guadalupe Canyon Road between Price Street to Bayshore Blvd.

- Working with Daly City, Colma, and Brisbane
- Field walk will be scheduled for May, would BPAC like to participate
- Goal is to provide a study that will be leveraged to apply for grants for future projects



#### **Alpine Road Project Initiation Document**

Description: Grant awarded and lead by MTC to start the Project Initiation Document for Alpine Road between Sand Hill Road and County limit with Portola Valley

- Grant award of \$990K
- Looking into Hwy 280 and Alpine on-ramps as well as other intersection along Alpine Road
- Led through our Traffic Engineering Division
- Continuation of the prior Alpine Road Study effort





## **Overview of Recent Storms**

- The County experienced an unprecedented amount of rain through the end of 2022 and into 2023
- Resulted in roadway failures, slip-outs, flooding, and 4 road closures
- To date, we have identified over 15 different locations that will require a future project
- Rain in February and March continue to impact the County and existing road failure sites
